## **Dr. Bill Robbins**

Patient presented with infection tooth #9. (X-rays and figs. 1 & 2)








I removed bridge #7-9 and crown #10 and amputated the teeth at the gum-line. I did a gingivectomy #4,6,13 and prepared #4,6,11,13 for crowns and placed a chair-side fabricated provisional bridge #4-6-11-13. I also made an impression for a lab fabricated provisional bridge #4-6-11-13 since it would be in place for several months. The laboratory fabricated provisional bridge was inserted (fig 3),

I then referred the patient to Dr. Rindler and he extracted #7,9,10, did connective tissue grafts #8,9 and placed implants #8,9. He also did functional crown lengthening surgery #4,6,13. After implants integrated, we placed a screw retained provisional, but is was long and unaesthetic and had screw access holes through facial (fig 4).





So we made impression for JKAD custom abutments and laboratory-milled screw retained provisional with pink gingiva, which was very esthetic (figs 5,6,7).



Ultimately we placed crowns #3,4,6,11,13,14 and the bridge from #7-10. (figs 8,9)
